Open: 1st January; Close: 9th February. Fees: Adult: £12.00, Youth: £10, Adults £15:00 on the day. Cheques / Postal Orders payable to: Hillingdon & Uxbridge M.C. If a non starter it is required that you explain your absence to the promoting club. Failure to do so is a breach of the Rules.
- COURSE:** 4 laps of 10 sections. 3 Routes. No roadwork.
- CLASSES:** A: - WHITE-Hard Route; B: - RED-Middle Route; C: - BLUE-Easy Route
- AWARDS:** Roy Pitson Twinshock Trophy to best rider on a genuine period twin-shock on the hard WHITE route. No other awards.
- MEDICATION:** It is your responsibility to declare at signing on if you are taking any drugs; you may be tested.
- GENERAL:** There will be no riding or practicing before or after the event, and no riding by anyone not entered in the event. **PENALTY: EXCLUSION.**
